The organization also provides veteran's specific employment services through its Homeless Veterans' Reintegration Program (HVRP) and provides financial assistance through various grants including FEMA, SSA Representative Payee, and the Emergency fund. Populations served include: Single Women, Single Men, Couples with Children, Mothers with children and Fathers with Children. Sub-populations include: Persons living with HIV/AIDS, Victims of Domestic Violence, Chronically homeless individuals, Ex-offenders, GLBTQ, and Persons with mental health/substance abuse issues.
